Benefits may be available without medical questions or exams.

During this year's open enrollment period, you can enroll in short-term and long-term disability insurance without answering medical questions.

- › If you enroll during this time, certain amounts of voluntary term life insurance may be available with no medical questions or health exams required:
- › Employee Guaranteed Issue Amount: \$500,000
- › Spouse Guaranteed Issue Amount: \$50,000
- › Dependent Child(ren) Guaranteed Issue Amount: \$10,000

You have the opportunity to apply for these voluntary benefits:

- › **Term life insurance** can help protect your loved ones' financial health if you are no longer there to support them.
- › **Accidental death & dismemberment (AD&D) insurance** pays benefits if you die or are seriously injured as a result of a covered accident.
- › **Short-term disability buy-up insurance** increases the benefit amount of your employer-paid STD plan, giving you a higher weekly benefit. Your employer-paid disability insurance may not be enough to cover your needs if you were to become disabled.
- › **Long-term disability insurance** pays benefits when you're disabled due to a covered injury or illness and are unable to work.
